- 3) All applications **MUST** include a **CLEAR** copy of the guest's photo ID card. **If the copy of the guest's photo ID card is not clear, the application will be denied.**
- 4) All students and guests must present a photo ID card at the dance.
- 5) CCA students may only bring **ONE** guest per dance.
